## 2. ST TRADE OBLIGATIONS

In compliance with Article 7.6 *Delegated Regulation 2017/583 of 14 July 2016 supplementing Regulation (EU) No 600/2014 of the European Parliament and of the Council on markets in financial instruments with regard to regulatory technical standards on transparency requirements for trading venues and investment firms in respect of bonds, structured finance products, emission allowances and derivative* we hereby inform you that where Banco Santander S.A. is the only SI in a given financial instrument and is also acting as the buying firm within the transaction, we will fulfil the post trade transparency obligations.

## 3. PERIODIC REVIEW

The list of financial instruments will be updated on a quarterly basis once ESMA publishes the official calculations of the SI regime.
